School Tuition Contract

This is a legally binding contract. Please read it carefully.

This contract is between Bourbon Christian Academy (“BCA”) and the parents/guardians (the “Parents”) of _____ (the “Student”). All persons signing this contract are jointly and severally liable for the tuition and fees in this Agreement. The Parent’s signature on this contract affirms the Parent’s understanding and agreement to the terms of the contract.

BCA acts in cooperation with parents who retain the primary responsibility for the education of their child. To carry out our mission on your behalf, we ask that you read the statements below and sign to indicate your agreement and support.

1. I understand BCA is a Christian school, which will accept only those students who have the ability to successfully pursue such a course.
2. I understand the school, in consultation with parents, has final responsibility for deciding the placement of my child in the proper grade level/courses.
3. I agree to support the spiritual, moral, dress, and disciplinary standards of the school and further agree that the school has the discretion in the discipline of my child while under school supervision.
4. I understand the school reserves the right, at the sole discretion of the Director, to suspend or dismiss any student who:
 - a. has a scholastic or conduct record, which is not in keeping with the best interest of the school.
 - b. develops a negative attitude toward the Christian philosophy of the school.
 - c. is disruptive of the school environment or educational process.
 - d. is found to be in the possession of or using drugs, alcoholic beverages, or tobacco products.
 - e. Students are representatives of BCA, and their behavior away from school should be consistent with a Christian lifestyle.

5. I understand that full cooperation of the home, including oversight of assigned homework and keeping in regular contact with my child's teachers, in the education of the whole child is expected. Habitual failure on my part to cooperate with the school will be considered grounds for dismissal of the student.

6. If problems arise regarding my child's education, I will discuss matters directly with my child's teacher(s) and/or the administration. I will attempt to resolve such matters in a manner consistent with Christian behavior.

7. I grant permission for my child to go on field trips, and to participate in school activities authorized by the school. I also grant permission for my child to be transported to field trips and activities through the means provided by the school, whether by carpooling, bus, or motor coach.

8. **Financial Contract:** *I understand BCA requires a financial commitment from each family for the entire school year. By signing this School Tuition Contract, I am faithfully committing to pay the full amount of my child's tuition for the entire year. I understand that payment of tuition is required for the full year including cases of disciplinary dismissal or voluntary withdrawal, except with Director approval. I understand that all fees and tuition owed to BCA must be paid before school records may be released if withdrawal is requested during the school year.*

Tuition for school year is \$3000 if paid at beginning of school year; \$3250 if paid in monthly payments of \$325/month for 10 months (beginning August 15) for grades K5-12th.

All monthly payments will be automatically deducted from a valid bank account of the Parent. There will be a \$50.00 NSF fee assessed for any payment returned insufficient. After the second NSF payment, the entire tuition balance will be due and monthly payments will not be accepted for payment.

9. I agree to abide by the policies and procedures of BCA, and to support school activities and programs to the best of my ability.
